Introduction

As part of the COVID-19 vaccination roll out, all school staff and all students aged 16 and over are now <u>eligible to receive a COVID-19</u> <u>vaccine</u>. All school staff are encouraged to make a vaccination booking as soon as possible and help keep our community safe.

I strongly encourage VCE teachers to get vaccinated as soon as possible as this will support the safe conduct of the VCE examinations this year. Secondary schools should also encourage exam invigilators to get vaccinated.

It is important for school communities and staff to have relevant and up-to-date information about COVID-19 vaccines, and to know that the vaccines approved for use in Australia are free and very effective at preventing serious illness and loss of life from COVID-19.

If you or staff in your school community have any questions or concerns you can talk to a GP, pharmacist or to a senior and experienced immuniser at Victorian <u>state-run sites</u>.

To help school communities understand and share important information about COVID-19 vaccines, we have put together this communications toolkit. This pack provides a range of materials including social media content, a poster, web banners, newsletter copy and FAQs and other resources to help school staff make informed decisions about their vaccination. It also provides helpful links to Commonwealth and State Government information resources about the vaccination program.

I encourage you to share and distribute these materials amongst your members to help increase vaccine uptake.

If further questions or concerns arise that are not covered in this pack, please do not hesitate to reach out to the Department representative in your area to provide feedback.

FAQs

I work in an education setting, am I eligible to receive a vaccine?

• As part of the COVID-19 vaccination roll out, all school staff and all students aged 16 and over are now eligible to receive a COVID-19 vaccine.

Which vaccine will I receive?

- Two vaccines are being used in Australia: the Pfizer vaccine and the AstraZeneca vaccine. Both vaccines protect you against COVID-19.
- Most people 60 years and older will receive the AstraZeneca vaccine, however, if you are between the ages of 18-39 you can choose to get the AstraZeneca with informed consent.
- Victorians aged 16-59 years will be offered the Pfizer vaccine as the preferred vaccine for people under 60 years old.
- People aged 18-59 years can choose to get AstraZeneca.

I already have had one dose of the AstraZeneca vaccine, but I am now eligible for Pfizer vaccine. Can I get Pfizer for my second dose?

- People aged 18-39 who have already booked for their first vaccine dose will be offered the Pfizer COVID-19 vaccine. People may choose to receive the AstraZeneca vaccine, if they provide informed consent.
- People aged 18-39 who have already had a first dose will be offered a second dose of the same vaccine brand as their first dose.

I am on extended leave (workers comp, maternity, long service), am I still eligible?

• Yes. Employees who are on extended leave can still receive a COVID-19 vaccination.

Are staff engaged through a labour hire agency (e.g. Casual Relief Teachers) eligible for vaccination?

• Yes – staff employed through a labour hire agency, including CRTs, can have a COVID-19 vaccine.

Can I make an appointment to be vaccinated during school or work hours?

- School based employees are encouraged to make appointments at times that minimise disruption to the educational program of the school and supports for students.
